1. Legal Assistant:- No. of vacancy (01)

- 1) Official from the Government Department possessing qualification of Degree in Law of a recognized University or equivalent and having experience of legal work in any Legal Department or practice of two years as an Advocate. 2) Official from the Government Department having Pay Level- 4 to Level -6.

2. Stenographer Grade I:- No. of vacancy (01)

Stenographer Grade I or Jr. Stenographer/Stenographer Gr. II with five years of experience in the Government Department/offices, holding analogues post.

3. Stenographer Grade II:- No. of vacancy (02)

Stenographer Grade - II or suitable official holding analogous post in any Government Department/offices with speed of 100 words per minute in short hand and 35 words per minute in type-writing/computer.

Pay and other terms & conditions of the officials on deputation shall be governed by the provisions laid down in the Department of Personnel & Training, O.M. No. 13/4/74-PER dated 20/11/2013 as amended from time to time.

The applicant should have a minimum of 4 years of service left as on the last date of receipt of application.

The selected candidate will be appointed on a deputation basis initially for the period of one year which may be extended from time to time as per the rules.


Only such recommendation/application, as are accompanied by the requisite personal data in Annexure -I will be considered.
