Eligibility:- Stenographer Grade I or Jr. Stenographer / Stenographer Gr. II with five years of experience in the Government Department/Autonomous Body.

Pay and other terms & conditions of the officials on deputation shall be governed by the provisions laid down in the Department of Personnel & Training, O.M. No. 13/4/74-PER dated 20/11/2013 as amended from time to time.

The selected candidate will be appointed on a deputation basis initially for the period of one year which may be extended from time to time as per the rules.
